Emergency Food and Clothing: Each neighbor in need receives at least 20 pounds of food, including fresh produce, meat, butter, cheese, and eggs. In addition to toiletries, 24 articles of clothing are offered to each family member, with children receiving new socks and underwear. 14,017 individuals were served in FYE 6/30/17.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)

Workforce Development: Those in need regularly report that unemployment has forced them to seek out ECHO's emergency services. Therefore, ECHO provides comprehensive workforce development programs such as: Job Search 101, Biannual Job Fairs, Free GED, Financial Literacy, Resource Builders, and ECHO Handmade. The majority of participants secure employment within three months of participation. 814 individuals were served in FYE 6/30/17.

ECHO Handmade: For those with significant barriers to employment, ECHO Handmade provides an immediate hands on work experience. Artisans are trained in the skills of sewing, leather work, jewelry making, or metal stamping. Raw materials are sourced directly from ECHO's donation center. Accessories are sold on the retail market. ECHO Artisans gain new skills, job histories, strong references, and an income.
